Nisha has advised on several Phase II merger reviews, including advising Schneider Electric and Temasek on their USD 2.1 billion acquisition of Larsen & Toubro's electric and automation business. This is India's first and only matter, where the CCI accepted purely behavioural remedies in a Phase-II merger review (without divestiture). She also led PayU's proposed acquisition of BillDesk, a USD 4.7 billion acquisition, which remains the only instance ever of the CCI approving a transaction unconditionally without remedies after issuing a show cause notice.

Nisha has received multiple accolades including Lawyer of the Year - Competition and Antitrust laws, Legal Era, Women Lawyer of the Year, ASSOCHAM National Legal Excellence Awards, ALB Private Practitioner of the Year and India & Middle East, ALB Woman Lawyer of the Year.
